## CITIZEN DESK CO-WORKING TERMS OF USE

### 1. Acceptance of Terms.

The services Citizen Desk, LLC. ("Citizen Desk") provides to you, the undersigned (including but not limited to use of office space, access to Internet, etc.), are subject to the following Terms of Use ("TOU"). Citizen Desk reserves the right to update the TOU at any time without notice to you.

### 2. Description of Services.

Citizen Desk may provide you with access to office space, work stations, Internet access, office equipment, conference space, knowledge resources, and other services as Citizen Desk may provide from time to time (collectively, "Services"). The Services at all times are subject to the TOU.

### 3. No Unlawful or Prohibited Use.

As a condition of your use of the Services, you will not use the Services for any purpose that is unlawful or prohibited by these terms, conditions and notices. You may not use the Services in any manner that could damage, disable, overburden, or impair any Citizen Desk server, or the network(s) connected to any Citizen Desk server, or interfere with any other party's use and enjoyment of any Services. You may not attempt to gain unauthorized access to any Services, or accounts, computer systems or networks connected to any Citizen Desk server or to any of the Services, through hacking, password mining or any other means. You may not obtain or attempt to obtain any materials or information through any means not intentionally made available through the Services.

You hereby represent and warrant that you have all requisite legal power and authority to enter into and abide by the terms and conditions of this TOU and no further authorization or approval is necessary. You further represent and warrant that your participation or use of the Services will not conflict with or result in any breach of any license, contract, agreement or other instrument or obligation to which you are a party.



#### 4. Use of Services.

You agree that when participating in or using the Services, you will not:

- h. Restrict or inhibit any other user from using and enjoying the Services;

  - III. not to use the Confidential Information in any way directly or indirectly detrimental to Citizen Desk or any participant or user of the Services.
- c. All Confidential Information remains the sole and exclusive property of Citizen Desk or the respective disclosing party. You acknowledge and agree that nothing in this TOU or your participation or use of the Services will be construed as granting any rights to you, by license or otherwise, in or to any Confidential Information or any patent, copyright or other intellectual property or proprietary rights of Citizen Desk or any participant or user of the Services.

## 7. Participation In or Use of Services.

You acknowledge that you are participating in or using the Services at your own free will and decision. You acknowledge that Citizen Desk does not have any liability with respect to your access, participation in, use of the Services, or any loss of information resulting from such participation or use.
